Local Water Done Well - Update

North Island Who's potentially looking at working together?



- Kaipara, Whangārei & Far North (noting that Far North & Whangārei prefer keeping services in-house)
- Auckland to retain ownership of Watercare (& Watercare will have access to increased borrowing for investment in water services)
- Hamilton & Waikato District
- Tauranga, Western Bays & maybe others
- Thames-Coromandel looking to join up with other councils could be Waikato Water Done Well (see below), Hamilton/Waikato or a Bay of Plenty sub regional grouping
- Rotorua Lakes preference is for delivering water services in-house until 2028, then having services delivered via a Rotorua Lakes CCO* or a multi-council owned CCO
- Waipā, Waitomo, Ōtorohanga, South Waikato, Taupō, Matamata-Piako, & Hauraki under the banner of Waikato Water Done Well (noting that Taupō would prefer keeping services in-house for now)
- · Whakatāne looking to join a multi council CCO with its neighbours to its east or its west
- Kawerau (preference for keeping services in-house)
- Ōpōtiki (preference for keeping services in-house)
- Gisborne (preference for keeping services in-house)
- New Plymouth, Stratford & South Taranaki
- Whanganui, Rangitīkei & Ruapehu
- Manawatū, Palmerston North, Horowhenua & Kāpiti Coast (noting that Manawatū & Kāpiti Coast would prefer keeping services in-house)
- · Central Hawke's Bay, Hastings, Napier & Wairoa
- · Carterton, Masterton, South Wairarapa & Tararua
- Wellington City, Upper Hutt City, Hutt City, Porirua City, and Greater Wellington Regional (GWRC) councils
