The story so far



Local Water Done Well is the Government's plan to address longstanding water infrastructure challenges

Implementation is in 3 stages:

- Repeal of previous legislation was completed Feb 2024. Timing was just before Councils were consulting on Long Term Plans (LTP's)
- Local Government (Water Services Preliminary Arrangements) Act (enacted Sept 2024)
 - Sets framework & preliminary arrangements for new water services system
 - Makes it easier to set up Council Controlled Organisations (CCOs)
- 3. Further legislation coming:
 - Omnibus Bill introduced December 2024
 - New regulatory framework for water services delivery
 - Expected to be passed by mid-2025





What happens next

LOCAL GOVERNMENT (WATER SERVICES PRELIMINARY ARRANGEMENTS) ACT

Water Services Delivery Plans (WSDP)

- . Council's must have a WSDP (individually or with other councils)
- 2. A one-off transitional requirement
- 3. Outline a council's intended water services delivery & implementation arrangements for their district.
- 4. Don't have to consult on the WSDP but do have to consult on:
 - Preferred model for delivering water services
 - Analysis of model + at least one other option
- 5. Must submit WSDP to Minister by 3 September 2025





What happens next

TYPES OF SERVICE DELIVERY ARRANGEMENTS

Councils must deliver water services by:

- I. Providing services itself (eg. ring-fenced business unit)
- 2. Transferring responsibility to a water organisation
- 3. Contracting another party
- 4. Entering into a joint arrangement (eg. joint CCO)
- 5. Become a shareholder in a water organisation established by council
- 6. Another type of arrangement (but not a franchise or concession agreement).





What happens next

NEW WATER SERVICES BILL

Brings all the changes together. Currently with Finance & Expenditure Select Committee

- Water service delivery models for councils to choose from
- Minimum requirements for <u>all</u> water service providers
- Ability to borrow up to 500 % of operating revenues (approx. x2 available now to councils)
- New approach for stormwater

What does this mean for NZ





organisations?

- Short term uncertainty for three waters capital intentions
- 'Mixed bag' of different water service arrangements
- New relationships
- Three waters activities in current Long Term Plans will be amended
- New planning & reporting documents for water services:
 - Statement of expectations (Prepared by shareholders & issued to water organisation/s they own)
 - Water services strategy (Prepared by water service providers)
 - Water services annual report (Prepared by water service providers)
- Delivery arrangements for stormwater may differ from wastewater & water supply


Water planning pipeline by project types




New Builds 41.4% Alterations/Additions/Repair/Maintenance 58.6%




Water planning pipeline by Regions






Value of Projects (\$bn)

Number of Projects




Central govt projects only 13.2% in number account for 41.3% in value




Water planning pipeline by Stage

This report is based on projects known to Pacifecon and other publicly available information as at mid February 2025. Some projects may not be entirely focused on water but will have a water infrastructure component.

For graphs including past \$\$, all \$\$ are in \$ of the day, no adjustments have been made for inflation.

In the Pipeline: projects at any of the following stages: Early Planning, In Planning, Tendering Phase.

With the release of local government Ten-Year Plans, Pacifecon introduced a new stage: 'Capital Intentions' to cover these more general statements of proposed forward capital expenditure. These \$amounts are not included in our pipeline of forward work - they are more strategic than specific construction work, but they will be on our research radar and will be reported once projects are approved by councils.

Lower Central North Island: Gisborne/Hawke's Bay, Taranaki, Manawatu/Whanganui and Wairarapa.

Upper South Island: Nelson/Marlborough and West Coast. Lower South Island: Otago and Southland.
